Authors are invited to prepare their abstracts and paper submissions, forwarding a soft copy via email to ncsustainability2024@gmail.com. To ensure a seamless submission process, authors are required to adhere to the following guidelines:

- Each paper should be accompanied by a cover page containing the paper's title, the author(s)' name(s), affiliations, complete postal addresses, email addresses, and telephone numbers.
- Research Papers must be presented in Word Document format, using Times New Roman font, 12-point size, 1.5 line spacing, 1-inch margins, and following the APA referencing style.
- The Research Paper should not exceed 4500 words and should encompass the following sections: Title, Objectives of the study, Methodology, Findings, Conclusion/Implications/ Recommendations, Limitations (if any), Acknowledgements (if appropriate), References, and Appendices (if applicable).
- Abstracts are to be limited to 350 words.
- If more than 10% of the paper is plagiarized- the research paper may be rejected and the same is notified to the author.

MCPS upholds a strict anti-plagiarism policy. Authors are expected to ensure the originality of their work. The selected candidates will be notified via email. The decision of the Review Committee regarding paper selection shall be considered final.

PUBLICATION OPPORTUNITY
